



## **OFFICIAL RULES ISAGENIX CELEBRATION 2022 EXPERIENCE GIVEAWAY**

1. **Eligibility:** The Isagenix Celebration 2022 Experience Giveaway (the “Sweepstakes”) is open only to members of Isagenix residing in the United States (including Puerto Rico) or Canada (excluding Quebec) with a qualifying entry as described in Section 4 below.
